Who can enter?	Only Australian residents who: (a) are aged 18 or over; and (b) hold a registered trading account with Specialist Wholesalers, including AAD (Participating Business) (Eligible Participant). Holding a trading account with any Specialist Wholesale group brand (and consequently, participation in this competition) is subject to the terms and conditions which apply to those trading accounts as amended from time to time.

Entry

General
