Terms and Conditions

Promoter	Specialist Wholesalers Pty Ltd (ABN 64 163 280 279), 327 Ferntree Gully Road, Mount Waverly, Victoria 3149 (Specialist Wholesalers).
Competition Period	12.01am (AEDT) on 01/11/2025 to 11.59pm (AEDT) on 12/12/2025.
Who can enter?	Only Australian residents who: (a) are aged 18 or over; (b) hold a registered trading account with Specialist Wholesalers (through a Bapcor Specialist Wholesaler group brand); and (c) are a principal of a business invited by the Promoter (or a Specialist Wholesalers Sales representative) to enter the competition (Participating Business). Holding a trading account with any Bapcor Specialist Wholesale group brand (and consequently, participation in this competition) is subject to the terms and conditions which apply to those trading accounts, agreed to at the time of account creation, as amended from time to time.
Who can't enter?	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition.
Where will the competition run?	The competition will run in respect of all participating Specialist Wholesalers channels in Australia.
Entry instructions	To automatically receive an entry, you must, on behalf of your Participating Business and after being invited by the Promoter (or Specialist Wholesalers Sales representative) to participate, during the Competition Period, meet or exceed your Participating Business' spend goal (Spend Goal) based on the total amount of sales dollars spent with the Promoter (using your registered Bapcor Specialist Wholesale trading account) during the eligible sales period (Eligible Sales Period) (i.e between 01/11/2025 and 12/12/2025 inclusive). For clarity, multiple purchases with the Promoter (using your registered Bapcor Specialist Wholesale trading account) can be made over the Competition Period in order to meet your Spend Goal. The Promoter will advise all Participating Businesses of their Spend Goal directly via email. However, purchases made before the Competition Period but within the Eligible Sales Period will be valid, subject to the above conditions, as reasonably determined by the Promoter.
How many winners will there be and how will they be chosen?	There will be 16 winners determined in respect of this competition – 15 minor winners and 1 major winner. There will be 1 draw conducted. The draw will be held at 11am (AEDT) on 14/01/2026 at 327 Ferntree Gully Road, Mount Waverly, Victoria 3149 . The first valid entry drawn randomly from the entries received during the Competition Period will win the major prize. The next 15 valid entries randomly drawn will each win a minor prize, awarded in descending order of value. The Promoter may draw additional reserve entries in a draw and record them in order, in case a winning entry/entrant is deemed invalid or a prize is unclaimed (Reserve Entrants).

Who will the prize go to?	Prizes will be awarded to the principal of a winning Participating Business who entered this competition. Entry
